**Valuation schedule.** Our standard program values covered livestock at current market value. But our optional valuation schedule can provide more flexibility. It amends coverage with values for types or categories of covered livestock that you and The Hartford agree aren't represented by current market value.

**Hypothermia coverage.** Adds hypothermia to our standard program as a covered cause of loss. Two conditions apply:

- Hypothermia is caused by exposure to freezing rain, sleet, blizzard, or snowstorm
- Hypothermia results in the death of your covered livestock

**Carcass removal coverage.** Adds the expense of carcass removal to our standard program if such carcasses are covered livestock that died as a result of a covered cause of loss.

**Contaminated feed or water coverage.** This protects your investment when the consumption of a toxic substance in feed or water results in the death of covered livestock.
